Scholarship Recipient

Some of you may wonder from time to time about how our past scholarship recipients are faring out there in the real world. A wonderful example of that recently appeared in the Spokesman Review where the article featured Conor Giorgi, a graduate of Eastern Washington University and the 2013 recipient of our Aspach-Engerbretsen Memorial Scholarship. Conor is the Anadromous Program Manager for the Spokane Tribe. He led the introduction of 51 adult Chinook Salmon into the Little Spokane River, the first salmon to swim there in 111 years! This is part of a larger effort to reintroduce sustainable salmon populations above Chief Joseph and Grand Coulee dams. Conservation Committee:

The following article appeared in the Coastal Conservation Association newsletter of August 27, 2021 Mainstem Columbia River Gillnets and Steelhead



This year's return of summer steelhead is a fraction of the recent 10-year average and is on track to be the worst dating back to the construction of Bonneville Dam in 1938. CCA has repeatedly sounded the alarm about the continued mainstem non-tribal gillnetting in the Columbia River's Zones 4-5, which is rarely monitored and

has never been subjected to the studies required to determine the number of steelhead caught, injured, and killed in this fishery as bycatch.

Under the bi-state Columbia River reforms, non-tribal gillnets were supposed to be completely transitioned out of the mainstem Columbia River. However, WDFW and ODFW continue allowing mainstem gillnetting during the fall season in Zones 4-5 (above Warrior Rock). Last month, WDFW and ODFW approved an initial eight fishing periods for non-tribal commercial gillnets in Zones 4-5 running from August 9 through September 2 - even as returns of summer steelhead hit record lows, including the ESA-listed "B-run" population destined for the Snake River.

NOAA Fisheries, the federal agency responsible for protecting ESA-listed salmon and steelhead, has largely looked the other way. In fact, in 2018 it approved a request by ODFW and WDFW to reduce the steelhead release mortality rate assigned to gillnets - a request that lacked the studies and detailed observations required for other fishing gears. This paved the way for the states to kill more steelhead as bycatch in the Zones 4-5 non-tribal gillnet fishery.

Despite having no scientific studies to substantiate their claims, gillnet advocates like Washington Fish and Wildlife Commissioners Donald McIsaac and Kim

Thorburn regularly claim gillnets as selective - including this latest public proclamation during an August 6 Washington Commission meeting. These Commissioners are also pressing the Oregon Commission to restore non-tribal gillnetting anywhere in the mainstem during the spring, summer, and fall seasons.

CCA has vigorously defended the bi-state Columbia River gillnet reforms, which have kept non-tribal gillnets out of mainstem Columbia River during the spring and summer seasons since 2017 - benefiting the conservation of wild and endangered salmon and steelhead populations. So far, the Oregon Commission is standing strong against these efforts.

Please take just a moment to email the Oregon Fish and Wildlife Commission at odfw.commission@odfw.oregon.gov and thank them for their commitment to the conservation of salmon and steelhead and urge them to reject Washington's efforts to return non-tribal gillnets throughout the mainstem Columbia River.

Fly of the Month: "Parachute Mr. Rapidan"

This month's fly is the Parachute Mr. Rapidan. This is a parachute version of the dry fly created by Harry Murray from Murray's fly shop in Virginia. It is a great mayfly pattern for March Browns in the spring. It is a great imitation for drakes in the summer in the larger sizes. The variegated colors of the dubbing used for the body is very realistic and water-proof. The low profile look of a parachute style fly makes an impression in the surface film that can trigger fish to eat it.



Material:

Hook - dry fly size 8-16
Thread - Brown, 17/0 trico thread on wing post
Tail - Moose body hair
Dubbing - Fly-rite # 34
Wing post - Yellow Mcflylon
Hackle - Grizzly and brown


