
Membership:

Fly of the Month: "Grey Ghost"

Carrie Steven's Gray Ghost is arguably the greatest feather wing streamer ever produced. Invented at her home at Upper Dam Maine, it has caught fish everywhere in the country from the early 20th century to today. The step-by-step sequences here show it tied using a vise, but Carrie Stevens never used a vise. The video shows the fly done "in hand", as she might have done it.

MATERIALS

Hook: Partridge Carrie Stevens 10xl Size 4 streamer hook or

Thread: White throughout, black at head with an orange

thread band

Tag: Flat silver tinsel **Body:** Orange floss

Underbelly: White bucktail under the shank, 4-6 strands of peacock herl over the shank

Throat: Bunches of white schlappen followed by a golden pheasant crest

Wing: Golden pheasant crest, then four gray hackles; crest and hackles are of equal length

Shoulders: Silver pheasant body feathers

Cheeks: Jungle Cock

Head: Black with an orange band
